I agree to remain in the Civilian Conservation Corps for the period terminating at the discretion of the United States between Sept 30, Oct 15, 1935 unless sooner released by proper authority, and that I will obey those in authority and observe all the rules and regulations thereof to the best of my ability and will accept such allowances as may be provided pursuant to law and regulations promulgated pursuant thereto. I understand and agree that any injury received or disease contracted by me while a member of the Civilian Conservation Corps cannot be made the basis of any claim against the Government, except such as I may be entitled to under the act of September 7, 1916 (39 Stat. 742) (an act to provide compensation for employees of the United States suffering injuries while in the performance of their duties and for other purposes), and that I shall not be entitled to any allowances upon release from camp, except transportation in kind to the place at which I was accepted for enrollment. I understand further that any articles issued to me by the United States Government for use while a member of the Civilian Conservation Corps are, and remain, property of the United States Government and that willful destruction, loss, sale, or disposal of such property renders me financially responsible for the cost thereof and liable to trial in the civil courts. I understand further that any infraction of the rules or regulations of the Civilian Conservation Corps renders me liable to expulsion therefrom. So help me God.

Willard Elton Knight returned to Coalgate, Oklahoma after working 9 months as a Laborer in CCC camp in Battiest, Okla. Finding no meaningful work he applied again for the CCC, indicating his road construction and farming experience might qualify him as a LEM (local experienced men), a position with higher pay and status.

Dependent is his father W. H. Knight.

Note: A search for his previous CCC enrollment records is indicated.

This Application for Enrollment was made at the local Coal County Relief Administration offices. Willard was approved for a second enrollment and assigned to CCC Co. 2814, SCS-17, Purcell, Oklahoma. He reported on August 19, 1935 and was inducted into the Purcell, Okla CCC camp.
